## REGISTRATION FEES

*Registration fees based on owner of dam at time of foaling. Only the owner at time of foaling can apply for registration.*

*Dam is required to be registered with the CBHA. Sire is required to be registered at the CBHA or US Belgian Corp. Sire needs to be DNA/JEB tested. Make sure all sections of the CBHA registration application are filled in, including: Birthdate, sire & dam names and registration numbers, all three owner names and signatures, breeding dates, and colour and markings on the back with the diagram.*

### FILLY/FEMALE REGISTRATIONS:

*Filly foals born in 2019 and after require DNA test at time of registration (registration fee + DNA \$60) below rates includes DNA fees*

<b>0-12 months of age inc. DNA</b>	\$110.00
<b>13-24 months of age inc. DNA</b>	\$210.00
<b>25-36 months of age inc. DNA</b>	\$270.00
<b>37-48 months of age inc. DNA</b>	\$340.00
<b>Over 48 months of age* inc. DNA</b>	\$400.00

*\*An application for registration of a Belgian over the age of 48 months will be considered for registration if the following criteria are met: The horse on the application for registration meets all of the requirements of the rules of eligibility as listed in the constitution of the Canadian Belgian Horse Association. Parentage verification by DNA typing of sire, dam and horse which the application for registration applies to. The laboratory fees and all relating DNA expenses are the responsibility of the person making the application for registration.*

### COLT/MALE REGISTRATIONS:

*All breeding stallions are required to be DNA&JEB tested before registering offspring. Testing at time of registration is not required.*

## MEMBERSHIP FEES

*In order for the Canadian Belgian Horse Association to start any work orders, you need to have a current membership or non-member rates apply. Non-member rates are double the standard fee. Memberships must be personal names. Company/businesses require letters of incorporation to be sent to the CBHA office for approval. Memberships are due January 1 of each year and are good until December 31. Memberships are paid per account. If you have personal and joint account, you'll have to pay both membership fees to keep both active.*

## TRANSFER FEES

*In accordance with the Livestock Pedigree Act, it is the SELLER'S responsibility to furnish the new buyer with a registration certificate in his/her name. Certificates, signed transfer form and fee to be sent to the CBHA office.*

*Transferred certificate will then be forwarded to new owner.*

*When selling, either at sale or privately, you need to fill out an application for transfer of ownership. All fields need to be filled in, including: horses name and registration number, Buyers name and full address, sale and delivery dates, and signature of current owner.*

### IMPORT FEES

*Once a US registered Belgian is purchased by a Canadian resident, the US certificate is no longer active.*

*A US transfer must be sent to the US Belgian Corp. The US Belgian Office will then send an email to the CBHA office with the name of the horse(s) and Canadian buyer(s). The CBHA Office will send a copy of the US papers for the Canadian buyer to verify the markings match the horse you bought. Those papers need to be signed and returned to the CBHA office with Import fee in order for a Canadian certificate to be issued.*

<b>0-6 months from Wabash date</b>	\$55.00
<b>After 6 months</b>	\$120.00

### DNA FEES

*All fillies born January 1, 2019 and after are required to be DNA tested prior to registration. All breeding stallions require DNA&JEB results on file before registering their offspring (tested through CBHA or US Belgian Corp.)*

*All test include DNA and Parentage Verification (when info is available)*

*Any Belgian whose parents are both DNA&JEB tested non-carriers of JEB, qualifies for "Parentage Verified non-carrier of JEB" and does not require JEB testing, but only needs a DNA test to prove parentage.*

*Send certificate or registration application of horse to be tested to the CBHA office with DNA fee. CBHA office will email or mail the kit.*

*You must PULL strands of hair from the mane and attach it to the kit. Pull the hair so that the bulb at the end is still attached. If there is no bulb at the end of the hair the lab will not be able to do any testing.*

*Mail kit to lab. When results are available the CBHA will record results and update certificate, returning it to the current owner.*

**DO NOT SEND HAIR TO CBHA OFFICE**

*Kits must be used within 2 months of processing date or fees are forfeited to CBHA.*

### FROZEN SEMEN FEES

*Frozen Semen certificates must be purchased and are required to be submitted at the time of registration of a foal the result of frozen semen. Anyone who froze semen in 2022 is required to file a Retained Frozen Semen Report by Jan. 31, 2023 plus the fee of \$20.00 per report. For complete rules pertaining to Frozen Semen contact the CBHA Director of your area or the CBHA office.*

### MISC. FEES

<b>Prefix (one-time fee)</b>	\$20.00

*When you begin to register horses with CBHA you need a prefix of your own to use in your horse's name. Prefix is a word or letters of your choice used exclusively by you for all the horses you register. (ex. "Prefix Horses Name" total of 30 characters)*

<b>Duplicate/Reissue certificate</b>	\$50.00

*When a Canadian registration certificate has been lost or destroyed the CBHA office will re-issue a new copy; fees paid by the current owner. A statutory declaration must be on file before new certificate is issued. New certificate will be marked "duplicate" and all other versions of certificate will be null and void.*
